

Kangra under sections 30, 30-A, 31, 34, 38, 39, 39-A, 39-B, 39-C, 81 and 83-A of the Himachal Pradesh Town and Country Planning Act, 1977, (Act No. 12 of 1977) and further, in exercise of the powers conferred by sub section (1) of section 77 of the said Act, the Governor, Himachal Pradesh is pleased to direct that the powers of the Director, Town and Country Planning under sections 30, 30-A, 31, 34, 38, 39, 39-A, 39-B, 39-C, 81 and 83-A of the said Act shall be exercised by the Town and Country Planner, Divisional Town Planning Office, Dharmshala, District Kangra, H.P. with respect to the Municipal Corporation Area Dharamshala also till further orders, subject to the following conditions.

(i) that the development permission is in accordance with the provisions of the Himachal Pradesh Town and Country Planning Act, 1977 (Act No. 12 of 1977), Himachal Pradesh Town and Country Planning Rules, 2014, regulations contained in the Development Plan for Dharmshala Planning Area and rules/instructions in this behalf issued by the State Government and the Town and Country Planning Department Himachal Pradesh from time to time.

(ii) that the Town and Country Planner shall function under the overall control of the Addl. Chief Secretary (TCP) to the Govt. of H.P. in respect of the powers delegated above; and


